INSTRUCTIONS TO SELECTED CANDIDATES

(NRI/NRI sponsored category. : ACADEMIC YEAR 2017-18)

Dear Candidate,

1. We are pleased to offer you an admission to the first year of **B.Tech.** (Branch as allocated) program in **Jaypee University of Information Technology, Wagnaghat** for the Academic year **2017-18** under NRI/NRI sponsored category.
2. **Fee Deposition (You are required to arrange remittance/deposition of fee as follows latest by 30/06/2017. See Remittance Instructions below.**
3. **Fee Structure:**
 - **Institutional Fee** (Annual) - **US\$6000** paid through NRI's foreign account or NRE account maintained in India.
 - **Hostel (Optional)Charges***(Annual) - **US\$1800** may be paid in INR equivalent to US\$1800 through Demand Draft in favor of 'Jaypee University of Information Technology' payable at Shimla.

*The fee and payment structure may be revised by the management from time to time.
4. **Registration:** You are required to register yourself with **JUIT,Wagnaghat** for the Academic Session **2017-18** in person on **July 20, 2017**. You are required to report at the University between 10.00 A.M to 3.00 P.M. for your Registration.
5. You will be allotted an Enrollment No. after Registration. The Enrollment No. is your personal identity and should be used for any reference with the Institute.
6. **You are required to bring the following at the time of Registration:**
 - (i) Character and Transfer/Migration certificate in original from the Head of the Institute/Board/University last attended.
 - (ii) Original and self attested copies of Marks Sheets and Certificate of High School and Intermediate or equivalent.
 - (iii) Medical certificate of fitness from MBBS qualified doctor (on his/her letter head or letter head of the hospital) indicating that you are free from any communicable disease. In case any student is suffering from or ever suffered from diseases which need immediate medical attention like Congenial Heart disease, Rheumatic Septal Deficiency, Bronchial Asthma, Epileptic Fits, Diabetes Mellitus etc, the same must be mentioned in the medical certificate also declared with the medical officer of the Institute at the time of joining to enable quicker and suitable response in case of emergency. The format of same may be downloaded from the website.
 - (iv) Four copies of passport size colored photograph.


NOTE: In case you are not able to submit any document listed above for the reason beyond your control, you may be allowed to submit the same latest by **September 30, 2017** after giving an undertaking and on obtaining approval of the same from the Vice Chancellor. In case you fail to submit the documents by the stipulated date, the admission shall stand cancelled.
7. **Refund Policy:** Those candidates who are given admission after they deposit the Institutional fee but wish to withdraw shall be refunded as follows:
 - (i) Candidates who wish to withdraw before registration / who fails to register on the specified dates i.e. **July 20, 2017**, shall be refunded after deducting the amount equivalent to US\$100.
 - (ii) In case the candidate register on **July 20, 2017** or later and then withdraws, the refund shall be made after deducting US\$600 per month @ pro-rata charges. Part of the month shall be treated as full month.
 - (iii) Hostel charges, if paid, shall be refunded full (less bank charges if any), if the hostel is not occupied. Otherwise one month deduction i.e. amount equivalent to US\$200 (For July & August) shall be made on withdrawal of hostel seat, and thereafter, it shall be on pro-rata basis for every part of the month (Part of the month shall be treated as full month).
 - (iv) No refund shall be admissible after **31 Aug 2017**.

- (v) The refund shall be made in the name of the Sponsor only and at the rate of conversion at which the money was received.
- (vi) Candidates who are given admission based on their performance in JEE shall be refunded the full amount less bank processing charges on payment of regular fee for JEE based admission.
8. NRI/NRI sponsored category, cannot be transferred to General Category (except when selected under JEE merit), anytime, after joining the program / closure of admission process.

General Instructions

9. Please note that the Institute reserves the right to withhold the result/cancel the admission at any time during the candidate's study period because of his/her submitting false information/ facts.
10. The candidate's acceptance to join the Institute will be taken as his/her acceptance to abide by all the conditions stated above or rules, regulations or standing orders issued by the Institute from time to time. Non observance of any of these conditions or rules, regulations, orders etc. can lead to the student's removal from the Institute.
