# **INSTRUCTIONS TO SELECTED CANDIDATES**

(2 YEARS M.TECH. PROGRAM: ACADEMIC YEAR 2017-18)

Dear Candidate,

1. I have great pleasure in informing you that based on your PGET-2017 merit you have been admitted to M.Tech. (Branch as allocated) program at Jaypee University of Information Technology, Waknaghat for the Academic Session 2017 – 18. The allocation of Branch/ Institution is final and no requests for change shall be entertained. The admission is subject to verification of your eligibility criteria.

## **Fee Deposition Schedule**

2. Fee Structure:
  - a) Institutional Fee : Rs. 50,000/- per semester (Rs. 1, 00,000/- per year).
  - b) Hostel Charges : Rs. 45,000/- per semester (Rs. 90,000/- per year).
3. To confirm your admission, you are initially required to deposit Rs. 10,000/- (Rupees Ten Thousand) (Non Refundable) out of total Institutional Fee of Rs. 50,000/- (Rupees Fifty Thousand) for first semester latest by July 15, 2017. You may choose any one of the following option as per your convenience.
  - a) Through Demand Draft in favour of "Jaypee University of Information Technology" payable at "Shimla"  
This can be deposited with the Accounts Department at JUIT, Waknaghat or may be sent by post to "The Registrar, Jaypee University of Information Technology, Waknaghat, P.O. Waknaghat, Teh Kandaghat, Distt. Solan, PIN-173 234, (H.P.), India". Cheques/Cash are not acceptable. Do not forget to write your name & your father's name behind the Demand Draft (DD). OR  
  
b) Through RTGS/NEFT: (Do not forget to send your UTR No. to mail ID as given below) Account Name: Jaypee University of Information Technology; Account Number: 0427032100000010; Bank Name: Punjab National Bank, Branch: JUIT, Waknaghat, IFSC Code: PUNB0637100, Account Type: Current.  
Mention your name and your father's name while transferring the fees and send the full details to Ms. Neha Arora at neha.arora@juit.ac.in, with your Unique Transaction Reference (UTR) Number. It will ensure linking of your transfer.
4. In case you do not deposit initial amount of Rs. 10, 000/- (Rupees Ten Thousand) by due date, your candidature shall be cancelled and seat transferred to the candidates next in merit of GATE/appearing in PGET-2017. No representation to extend the date of submission of dues is accepted under any circumstances.
5. Hostel (Optional): Please note that Hostel facility is limited. If you want to opt for hostel seat, mail to registrar@juit.ac.in.

## **Registration Schedule**

6. You are required to present yourself, along with following fee & documents on July 18, 2017 i.e. the date of your registration & commencement of classes.
  - Bank Draft of Rs. 40,000/- (Balance of Institutional Fee) in favour of "Jaypee University of Information Technology" payable at "Shimla".
  - Character and Transfer/Migration certificate in original from the Head of the Institute/Board/University last attended.
  - Original and self attested copies of Marks Sheets and Certificates of High School and Intermediate (10+2) or equivalent.
  - Original and self attested copies of Marks Sheets and Certificates of the qualifying Examination i.e. B.E/B.Tech/M.Sc. entitling you for the admission to this course.
  - A copy of your AADHAAR card.
  - Medical certificate of fitness from MBBS qualified doctor (on his/her letter head or letter head of the hospital) indicating that you are free from any communicable disease. In case any student is suffering from or ever suffered from diseases which need immediate medical attention like Congenial Heart disease, Rheumatic Septal Deficiency, Bronchial Asthma, Epileptic Fits, Diabetes Mellitus etc, the same must be mentioned in the medical certificate also declared with



the medical officer of the Institute at the time of joining to enable quicker and suitable response in case of emergency. The format of same may be downloaded from the website.

- Four copies of passport size colour photograph.

NOTE: In case you are not able to submit any document listed above for the reason beyond your control, you may be allowed to submit the same latest by September 30, 2017 after giving an undertaking and on obtaining approval of the same from the Vice Chancellor. In case you fail to submit the documents by the stipulated date, the admission shall stand cancelled.

## **Refund Policy**

7. Kindly note that no refunds are admissible from the initial payment of Rs. 10, 000/- (Rupees Ten Thousand).
8. Once the candidate registers on July 18, 2017 or later & thereafter wishes to withdraws, he/she shall be refunded after deductions @ of Rs. 8,000/- per month [pro-rata of balance amount paid at the time of registration i.e. Rs. 40,000/- (Rupees Fifty Thousand) (semester being of 5 months)]. Please note that part of the month shall be treated as full month. Hostel Charges is fully refundable in case of candidate not joining the Program i.e. before registration and thereafter it shall be made after deducting pro-rata monthly charges.
9. No Refund shall be made after August 31, 2017 i.e. the date of closure of admission process for M.Tech. Program.

10. Please note that the Institute reserves the right to withhold the result/cancel the admission at any time during the candidate's study period because of his/her submitting false information/ facts.
