## 2. GENERAL INSTRUCTIONS

2.1 The medium of instruction in the University is English.

2.2 Application Forms:

- a) Application forms for all programs of admission are available online at [www.jiit.ac.in](http://www.jiit.ac.in). Apply online through the website in <https://getadmissions.com/jaypee> or collect offline forms from the admission counter of the University.
- b) Candidates must ensure that mail ID and mobile phone number entered in the application form is continued till completion of admission process. All correspondence will be carried out on the registered email IDs. Mail ID once registered cannot be changed. Candidates are advised to use personal mail IDs and not to use corporate mail IDs.
- c) Follow the on-screen prompts to fill up the application form and make the payment through Credit card/Debit card/Net banking/UPI.
- d) Once the payment is successful, an Application ID shall be allotted to the candidate, which must be preserved for future reference. The candidate shall also get an e-mail of confirmation.
- e) During the online application, candidates are required to upload the passport size photograph of self and signatures of self and parent.
- f) Candidates are advised to keep a copy of the application form for their reference.
- g) Candidates can apply for more than one mode of admission. For example, if a candidate is applying under JEE (Main) 2024 category and also wants to apply under 10+2 basis or NRI category, the candidate must fill separate forms and pay the required application fee.

2.3 Applications received after last date will not be accepted and candidates shall have no claim on the merit list and subsequent admission to the program.

- 2.4** The candidates are advised to check the website of the University for latest updates.
- 2.5** Display of Application Status-Candidates can see the receipt details of their applications on the JIIT website within two working days of submission of the application form.
- 2.6** Candidates appearing in qualifying examination in 2024 are also eligible to apply, however, the final result of the qualifying examination must be submitted before the preparation of merit, latest by 31 May 2024.
- 2.7** In case any state board issues a single transcript / DMC mentioning the marks in 10+1 and 10+2, then for such boards, average marks of both 10+1 & 10+2 will be taken into account while preparing the merit for 10+2 based admission.
- 2.8** Candidates to upload following documents by 31st May 2024. Applications with incomplete documents on the last date of application will not be considered for the admission process.
- For UG Program:10+2 mark sheet.
  - For PG Program: final year result or pre-final year/ semester mark sheet (for candidates appearing in qualifying examination in 2024).
  - For Diploma Program: 10th mark sheet.
- 2.9** Candidates will be considered for admission strictly in order of merit. Selected candidates will be offered provisional admission, subject to verification of certificates of eligibility/qualification and depositing applicable academic fee.
- 2.10** All admissions will be subject to verification of facts from the original Certificates/documents of the candidates. If an applicant is found ineligible at a later stage after admission to the University, the admission will stand automatically cancelled. The decision of the Admissions Committee of the University regarding the eligibility for admission to the program shall be final and binding on the candidate.
- 2.11** Ensuring eligibility for the admission to the program, under the defined category of admission, is the sole responsibility of the candidate.
- 2.12** Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).

## 5. RESERVATION OF SEATS

**5.1** Reservation for SC/ST candidates will be as per the provisions of Gol for all programs.

**BTech & Integrated MTech Program:**

**5.2** For admissions, 50% seats shall be filled through counselling based on JEE (Main) 2024. All India Rank (AIR) and 50% seats shall be filled through counselling based on merit, drawn on the basis of marks of 10+2 examination.

**5.3** Vacant seats are inter-transferable in either category i.e. JEE (Main) AIR based to 10+2 marks based and vice- versa.

**5.4** Tuition Fee Waiver(TFW): 1 % seats in BTech program shall be offered under TFW scheme. Seats will be allocated on merit. Candidates with family income less than 8 lakhs per annum are eligible. Valid Income Certificate issued by the State Authorities will be accepted.

- 5.5 Prime Minister's Special Scholarship Scheme (PMSSS): 2 seats per course at JIIT, Noida are reserved for J&K students under this scheme.
- 5.6 Concession for the wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu Families (non-migrants) living in Kashmir valley for admission at JIIT Noida will be as per MHRD letter No. 3-4/2017-NER dated October 15, 2019.

## 6. JEE MAIN 2024 ALL INDIA RANK BASED BTech AND INTEGRATED MTech

- 6.1 Candidate's who have passed 10+2/equivalent exam in 2022, 2023 or appearing in 2024 are eligible to apply.
- 6.2 Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).
- 6.3 Candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or equivalent examination and should have secured a Pass grade in all subjects.
- 6.4 The candidate should have passed or appeared in 10+2 examination or its equivalent with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Agriculture, Engineering Graphics, Business Studies, Entrepreneurship.
- 6.5 The merit list amongst the Applications received for admission to Jaypee Universities shall be drawn based on JEE (Main) 2024 AIR. Rank in no other category will be considered.
- 6.6 **CHOICE(S) OF INSTITUTES/BRANCHES** - During counselling the candidate will need to select any one Institute/University and give choice for any/all the programs of that Institute/ University.
- 6.7 **COUNSELLING INTIMATION:**
- Counselling will be based on Merit. Candidates eligible for counselling on a specific date will be informed.
  - Intimation will be sent by Email on registered mail ID's.
  - Ignorance/lapses, if any, in participating in the allotted counselling slot shall not be accepted as an excuse to participate in counselling at a later date.

### 6.8 COUNSELLING

The first round of counselling will be common and conducted at JIIT Noida for admissions to all the four universities, i.e. JIIT-Noida, JUIT-Waknaghat, JUET-Guna and JU-Anoopshahr. The subsequent round (s) of counselling will be held in respective Universities.

#### Process of Counselling:

- 1st round of counselling shall be held at JIIT-Noida on 25-26 June 2024. Candidates are advised to check their Email for the counselling intimation.
- All candidates (including appearing in 10+2 examination in 2024) are required to upload their results on getadmissions portal latest by 31 May, 2024.
- Candidates called for counselling are permitted to exercise choice of only one University at the time of Counselling (No inter-university transfers are allowed).
- Allocation of seats will be as per merit of JEE(Mains) 2024 AIR.
- Candidates shall be allowed to exercise choice of any program/branches within the selected University (Thus, the candidate shall have the option of up-gradation in the programs /branches as per the merit and priority of choices exercised by them but within the same university).
- Seats in the programs shall be allocated on the basis of preferences indicated at the time of counselling.
- During counselling a candidate can confirm the seat available or choose to be in wait list by depositing Rs. 75000/- (seventy-five thousand). The amount will be adjusted against academic fee dues of first



semester for candidates who are offered admission or will be kept as wait listed fee till admission is offered.

- h) Fee can be deposited through Debit Card/credit Card / UPI / Demand Draft favoring “Jaypee Institutes Admission Account” payable at Noida/Delhi. (Cheque and Cash are NOT acceptable.)
- i) On allocation of a seat, candidate will be offered Provisional Admission Letter.

**Note:**

- i. Candidates are advised to judiciously fill their choice form at the time of counselling.
- ii. The candidates have the option of freezing confirmed seats allotted to them any time before up-gradation is carried out, if they are satisfied with their allotted program and they do not want any further changes through up-gradation.

## 7. BTech AND INTEGRATED MTech (10+2 MARKS BASED)

- 7.1 Candidate's who have passed 10+2/equivalent exam in 2022, 2023 or appearing in 2024 are eligible to apply.
- 7.2 Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).
- 7.3 Candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or its equivalent examination and should have secured a Pass grade in all subjects.
- 7.4 The candidate should have passed or appeared in 10+2 examination or its equivalent with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Agriculture, Engineering Graphics, Business Studies, Entrepreneurship.
- 7.5 Merit will be prepared on marks scored in Maths, Physics(both compulsory subjects) & one subject as mentioned in para 7.4 above.
- 7.6 First round of counselling will be held on 12-13 June 2024. Further rounds will be held based on vacancies. Candidate will be called for counselling as per merit. Candidates are advised to check their email for the counselling intimation.
- 7.7 Counselling intimation will be as mentioned in para 6.7 above.
- 7.8 Candidates appearing in 10+2 examination in the year 2024 are responsible for uploading their results on getadmissions portal latest by 31 May 2024.
- 7.9 Applications with incomplete documents/results of 10+2 will not be considered for counselling.
- 7.10 In case any state board issues a single transcript / DMC mentioning the marks in 10+1 and 10+2, then for such boards, average marks of both 10+1 & 10+2 will be taken into account while preparing the merit for 10+2 based admission.

**Process of Counselling:**

- a) Candidates as per merit list, who are called for counselling shall be allotted seats on the basis of merit drawn on marks scored in 10+2 in the 3 subjects as given in para 7.5 above.
- b) Candidates shall be allowed to exercise choice of all programs/branches. The candidate will be upgraded in the programs /branches as per the merit and priority of choices exercised by them.

**During counselling a candidate can confirm the seat available or choose to be in waitlist by depositing Rs. 75000/- (seventy-five thousand). The amount will be adjusted against academic fee dues of first semester for candidates who are offered admission or will be kept as wait listed fee till admission is offered.**

- c) Fee can be deposited through Debit Card/credit Card / UPI / Demand Draft favoring “Jaypee Institute of Information Technology” payable at Noida/Delhi. Cheque and Cash are NOT acceptable.
- d) After getting a seat student will be offered Provisional Admission Letter.

**Note:**

- i. Candidates are advised to judiciously fill their choice form at the time of counselling.
- ii. The candidates have the option of freezing confirmed seats allotted to them any time before up-gradation is carried out, if they are satisfied with their allotted program and they do not want any changes.

## 8. DIRECT ADMISSION IN BTech PROGRAMS-EE (VLSI), EC(ACT), ECM, M&C

- 8.1 Direct admission will be offered for few seats in BTech programs in Electronics Engineering (VLSI Design and Technology), Electronics and Communication (Advanced Communication Technology), Mathematics and Computing (M&C) and Electronics and Computer Engineering (ECM) only.
- 8.2 Candidates should have minimum of 60% marks (55% for SC/ ST) in aggregate in 10+2 or its equivalent examination and should have secured a pass grade in all subjects. Merit will be prepared on marks scored in Maths, Physics (both compulsory subjects) & one subject as mentioned in para 7.4 above.
- 8.3 Candidates desirous for Direct Admission will have to select the option for direct admission in 10+2 based application form (for Non-Bio candidates).
- 8.4 Separate application number for Direct Admission (DAGxxxxxx) will be generated and sent to the applicant.
- 8.5 Candidate can take admission in only one program. Admission in the program will be offered as per merit.
- 8.6 Candidates being considered for Direct Admission will be informed through Email.
- 8.7 Candidates on being offered admission can confirm the seat by depositing Rs. 1,00,000/- (One Lakh) as partial academic fee. Balance fee will be deposited as per admission offer letter.
- 8.8 Fee can be deposited through Debit Card/credit Card / UPI / Demand Draft favoring “Jaypee Institute of Information Technology” payable at Noida/Delhi. Cheque and Cash are NOT acceptable.
- 8.9 On confirming direct admission in the related program and on deposition of partial fee, the candidate will not be considered for admission to any other BTech program(i.e. all other applications for admission to any BTech program will be cancelled).

**Note:** There will be no change of program and up-gradations under this category

## 9. NRI/NRI SPONSORED CATEGORY

- 9.1 Candidate's who have passed 10+2/equivalent exam in 2022, 2023 or appearing 2024 are eligible to apply.
- 9.2 Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).
- 9.3 Candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or its equivalent examination and should have secured a Pass grade in all subjects.
- 9.4 The candidate should have passed or appeared in 10+2 examination or its equivalent with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Agriculture, Engineering graphics, Business Studies, Entrepreneurship.
- 9.5 The merit shall be drawn as follows:  
**Merit for BTech CSE/ECE/IT programs:-** Physics, Mathematics are compulsory subjects and one other subject from the list above (highest score will be considered).  
**Merit for BTech Biotechnology program:-** Physics and Chemistry as compulsory subjects and any one subject out of Biology, Biotechnology or Mathematics.
- 9.6 Candidates who take admission under NRI/NRI sponsored category cannot opt for change to General/ Non-NRI category in subsequent years of the entire program duration.
- 9.7 The sponsorship letter from NRI or NRI certificate (as applicable) and the sponsor's passport copy to be

attached along with the application form.

- b) **Inter-University Migration** – for BTech 1st year candidate admitted in 2023- Completing first year B. Tech in 2024 from a recognized university with 60% (55% for SC/ST category) or equivalent CGPA and 60% aggregate in 10+2. Candidate to produce the migration certificate / NOC from the Institute /University currently studying.

**11.2** Candidates should have passed in all subjects of the qualifying examinations as applicable for applying.

### 11.3 Admission Process:

#### a) Inter-University Migration – Conditions

- (i) Candidate to submit the curricula / scheme of teaching of the first year of the program from his University.

Or

- c) **CUET (UG):** Admission will be offered based on merit of CUET (UG) marks scored in General Test + English + one of the other subjects (Accountancy, Business Studies, Computer Science / Informatics Practices, Economics, Mathematics, Chemistry, Physics, Biology/Applied Mathematics, Psychology,

Sociology/ Biochemistry/ Biotechnology/ Entrepreneurship/ Legal Studies/ Mass Media/ Mass Communication).

- c) Merit List of qualified candidates will be prepared and selected candidates will be offered admission.

**13.3** Candidates appearing in 10+2 examination must submit their results latest by 31 May 2024.

**13.4** Duration of the Program (3 or 4 years):The degree in the program will be awarded as follows:

- (a) BBA degree after successful completion of 3 years (6 semesters) of program.  
(b) BBA with Research/ Academic Projects/ Entrepreneurship degree after successful completion of 4 years (8 semesters) of program.

## 14. BCA PROGRAM

### 14.1 Eligibility:

## 15. BSc (CS) PROGRAM

### 4. GENERAL ELIGIBILITY CRITERIA FOR ADMISSION

**BTech Programs**

- a) Candidate's who have passed 10+2/ equivalent exam in 2022, 2023 or appearing in 2024 are only eligible to apply for the Program.
- b) Candidates with gap year (if any) between their 10+2 and admission to BTech Program, will be required to submit Gap Period affidavit as per the format available at University Website.
- c) For JEE (Mains) based admission, candidates should have qualified JEE (Mains) – 2024 All India Rank (AIR) and should have passed or appeared in 10+2 Examination or equivalent (as defined in JEE (Mains) 2024) with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational



Subject, Engineering Graphics, Business Studies, Entrepreneurship and English from any recognized Board.

- d) For 10+2 marks based admissions, candidates should have minimum of 60% marks (55% for SC/ ST) in aggregate in 10+2 or its equivalent examination.
- i. 10+2 marks based Non-JEE Candidates for admission in branches other than Biotechnology / Bioinformatics: The candidate should have minimum of 60% aggregate marks (55% for SC/ST) in aggregate in 10+2 or its equivalent examination with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Engineering Graphics, Business Studies, Entrepreneurship and English. CUET-UG-2024 qualified candidates shall also be considered for admission to BTech Program.
  - ii. 10+2 marks based Non-JEE Candidates for admission in Biotechnology /Bioinformatics:  
The candidate should have minimum of 60% aggregate marks (55% for SC/ST) in aggregate in 10+2 or its equivalent examination with Biology/ Biotechnology as compulsory subjects alongwith two subjects out of Physics, Mathematics, Chemistry, Computer Science, Information Technology, Informatics Practices, Technical Vocational Subjects, Electronics, Entrepreneurship, Engineering Graphics, Business Studies and English. CUET-UG-2024 qualified candidates shall also be considered for admission to BTech Program.
- e) **BTech (Lateral Entry) Directly to 2nd Year** – The candidate should have passed / appeared (in final semester/year) 03 Year Diploma Program with 60% (55% for SC/ST) aggregate marks or its equivalent CGPA from recognized Board / University. Candidates who have passed BTech 1st Year Examination with 60% (55% for SC/ST) aggregate marks or its equivalent CGPA from the recognized University / Institutions are also eligible for admission to the Program.
- f) **BBA Program** – Candidate should have passed 10+2 or equivalent examination from a recognized educational board with minimum 60% (55% for SC/ST) aggregate marks in aggregate or equivalent grade. CUET-UG-2024 qualified candidates shall also be considered for admission to BBA Program.
- g) **BSc Program** – Candidate should have passed 10+2 or equivalent examination from a recognized educational board with minimum 60% (55% for SC/ST) aggregate marks in aggregate or equivalent grade with Mathematics as a compulsory subject. CUET-UG-2024 qualified candidates shall also be considered for admission to BSc Program.
- h) **MSc Program in Physics** – Candidate should have passed BSc (Hons)/ BSc under 10+2+3 pattern securing minimum of 50% aggregate marks (45% for SC/ST) or equivalent grade point on a 10 point scale in aggregate with Physics as a compulsory subject. Candidates having CGPA  $\geq 7.5$  or equivalent percentage in qualifying examination will be considered for merit-based admission to MSc Program. CUET-PG-2024 qualified candidates shall also be considered for admission to MSc Program.
- i) **MSc Program in Biotechnology, Microbiology** –
- i. **Non DBT Biotechnology/ Microbiology** – Candidate should have passed BSc(Hons)/ BSc or an equivalent Undergraduate Degree in any branch of Life Sciences/ Medical Sciences/ any branch of Biology under 10+2+3 pattern securing 50% aggregate marks (45%forSC/ST) or equivalent grade point on a 10 point scale in aggregate. Candidates having CGPA  $\geq 7.5$  or equivalent percentage in qualifying examination will be considered for merit-based admission to MSc Program. CUET-PG-2024 qualified candidates shall also be considered for admission to MSc (Microbiology)/ MSc (Biotechnology) Program.
  - ii. **DBT Supported MSc Biotechnology** – 10 Seats of MSc (Biotechnology) program are supported by DBT and admission to such seat is through Qualified Rank of GAT-B-2024 in order of merit. Students admitted against such seats are awarded with fellowship amount of Rs. 5000/- per month.
- j) **M Tech Program** – Candidate should have passed four year Bachelor's degree in the relevant discipline with minimum 60% (55% for SC/ST) marks or equivalent grade point on a 10 point scale in aggregate from a recognized University / Institution. Admission is through PGET (PG Entrance Test) conducted by Jaypee University of Information Technology. The condition of admission on the basis of merit of PGET Test for candidates having CGPA  $\geq 7.5$  or equivalent percentage in qualifying examination has been relaxed and such candidates will be offered merit-based admission to the MTech Programme. GATE Qualified candidates are exempted from PGET Entrance Test. However, they have to appear for the interview. CUET-PG-2024 qualified candidates shall also be considered for admission to MTech Program.

- k) **PhD Program** – UG & PG (Regular Mode only) with 60% (55% for SC/ST) aggregate marks from the recognized University/ Institution in the relevant field at PG Level. Selection will be based on the PhD Entrance test followed by interview conducted by Jaypee University of Information Technology. NET/ SLET/ UGC/ CSIR (JRF) candidates are exempted from the PhD Entrance Test but have to appear for the interview.

All candidates who are offered provisional admission will be required to produce proof of having passed the qualifying examination to the University authorities latest by September 30, 2024 failing which, such provisional admission will stand automatically cancelled. ## 6. RESERVATION OF SEATS

- Reservation for SC/ST/ candidates will be as per the provisions of GOI for all programs.
- For admissions in Biotechnology and Bioinformatics programs, 50% seats shall be filled on the basis of JEE (Main) 2024 All India Rank and 50% seats shall be filled on the basis of 10+2 marks with Biology/ Biotechnology as core subject in 10+2 examination. However, seats are inter-transferable in either category considering number of applications to each category.
- For JUIT, Wagnaghat, 50% seats shall be allotted through JEE (Main) 2024 All India Rank. Remaining 50% seats shall be filled through Counseling based on merit, drawn on the basis of marks of 10+2 examination. However, seats are inter-transferable in either category considering number of applications to each category.
- 10% seats at JUIT, Wagnaghat for BTech program only are reserved for wards of serving and retired Armed Forces and Paramilitary Forces Personnel. 30% concession in Tuition Fee for wards of serving and retired Armed Forces and Paramilitary Forces Personnel will be provided to candidate admitted under such category for BTech program only. Additional 5% concession (i.e. 35%) in Tuition Fee will be provided for wards of War Widows and personnel killed in action or persons with disability during the services.
- 10% seats at JUIT, Wagnaghat are reserved for Himachal Pradesh (HP) category candidates only subject to the condition that candidate has qualified the 10+2 examination from any of the schools/Institutions located in the state of Himachal Pradesh.

Reservation for the wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu Families (Non- Migrants) living in Kashmir valley for admission at JUIT Wagnaghat as per MHRD letter No. 3-4/2017-NER dated October 15, 2019.

## 7. ADMISSION PROCEDURE - JEE MAIN 2024 ALL INDIA RANK BASED BTech

- a) Candidates who have passed 10+2/equivalent exam in 2022, 2023 or appearing in 2024 are only eligible to apply for the program.
- b) Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).
- c) Candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or equivalent examination and should have secured a Pass grade in all subjects.
- d) The candidate should have passed or appeared in 10+2 examination or its equivalent with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Agriculture, Engineering Graphics, Business Studies, Entrepreneurship.

- e) The merit list amongst the Applications received for admission to Jaypee Universities shall be drawn based on JEE (Main) 2024 AIR. Rank in no other category will be considered.
- f) **CHOICE(S) OF INSTITUTES/BRANCHES** - During counselling the candidate will need to select any one Institute/University and give choice for any/all the programs of that Institute/ University.
- g) **COUNSELLING INTIMATION:**
- h) Counselling will be based on Merit. Candidates eligible for counselling on a specific date will be informed.
- i) Intimation will be sent by email on registered mail ID's.
- j) Ignorance/lapses, if any, in participating in the allotted counselling slot shall not be accepted as an excuse to participate in counselling at a later date.
- k) **COUNSELLING**

**Process of Counselling:**

- f) Seats in the programs shall be allocated on the basis of preferences indicated at the time of counselling.
- g) During counselling a candidate can confirm the seat available or choose to be in waitlist by depositing Rs. 75000/- (seventy-five thousand). The amount will be adjusted against academic fee dues of first semester for candidates who are offered admission or will be kept as wait listed fee till admission is offered.

## 19. REFUND POLICY

Last Date of admission is as announced by the UGC. If a student leaves the program, fee shall be refunded as per the latest Tuition Fee refund policy Notified by UGC for the year 2024-25. ### Refund of Hostel Charges:

Application forms can also be obtained by post by sending a demand draft to “Admission Cell, Jaypee University of Engineering & Technology, AB Road, Raghogarh, Guna-473226(M.P.)”.
- 2.2 Candidates who procure the application form after payment of application fee are not required to make any further payment while submitting the application form.
- 2.3 If a candidate is applying for JEE (Main) 2024 based admission and also wants to apply under NRI Category/10+2 marks based admission, he/she must apply separately.
- 2.4 Applications received after last date of submission will not be accepted and candidates shall have no claim on the merit list and subsequent admission to the program.
- 2.5 Hosting of the offline Application Forms on the websites of the Universities shall be done in a phased manner. Therefore the candidates are required to check the websites of the respective Universities for the latest updates, and also take necessary action as per the information hosted on the websites.
- 2.6 Display of Application Status: Candidates shall generally be able to see the receipt details of their applications and essential data on the website only after 7 working days of submission of the Application form.

## 4. GENERAL ELIGIBILITY CRITERIA FOR ADMISSION

### 4.1 B Tech Programs :

- a) Candidates who have passed 10+2/Equivalent exam in 2022, 2023 or appearing in 2024 are eligible to apply.
- b) The candidate should have passed or appeared in 10+2 examination or its equivalent (as defined in JEE (Main) 2024 examination) with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Informatics Practices, Technical Vocational Subject, Agriculture, Engineering Graphics, Business Studies, Entrepreneurship and English. For Civil Engineering/Chemical Engineering/Mechanical Engineering Programs Chemistry is must with Physics and Mathematics.
- c) For JEE (Main) based admissions, candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or its equivalent examination.
- d) For 10+2 marks based admissions, candidates should have minimum of 60% marks (55% for SC/ ST) in aggregate in 10th class or its equivalent examination. Other conditions will remain same as above.
- e) Candidates with gap year (if any) between their 10+2 and admission to BTech, MTech, and Diploma will be required to submit an Gap Period affidavit available at University Website.

**4.2 Diploma Program** - Candidate should have passed 10th or equivalent examination from a recognized educational board with Science and Mathematics as subjects.

**4.3 MSc Program in Physics, Mathematics, Statistics and Chemistry** – Candidates should have passed BSc (Hons)/BSc under 10+2+3 pattern securing the minimum of 55% marks (50% for SC/ST) or equivalent grade point on a 10 point scale in the aggregate in Science subjects (considering all the three years of BSc course). The subject in which admission is sought must be the Hons. subject at BSc (Hons.) Level/ a subject studied in all three years at graduate level.

**4.4 MTech Program** – Candidates should have passed BE/BTech examination with 60% marks or 6.0 CGPA on 10 point scale in the relevant discipline.

**4.5 PhD Program** – PG degree with 55% (50% for SC/ST) marks from a recognized University/Institution in the relevant subject. Admission will be based on the PhD entrance test followed by interview conducted at JUET, Guna. NET/SLET/GATE qualified candidates are exempted from appearing in the PhD Entrance test but have to appear in the interview.

**4.6** All candidates who are offered provisional admission will be required to produce proof of having passed the qualifying examination to the University authorities latest by September 30, 2024 failing which, the provisional admission will stand automatically cancelled. No representation for extension of dates, for whatsoever reasons, shall be entertained.

**4.7** All admissions will be subject to verification of facts from the original certificates/documents of the candidates. If an applicant is found ineligible at a later stage after admission to the University, his/her admission will stand automatically cancelled. The decision of the Admissions Committee of the University regarding the eligibility for admission to the program shall be final and binding on the candidate.

**4.8** Ensuring eligibility for the admission to the program, under the defined category of admission, is the sole responsibility of the candidate.

**4.9** Candidates appearing in qualifying examinations prescribed above in the year 2024 can also apply for admission. However, if admission is based on marks in the qualifying examination, the result of the examination must be submitted before the preparation of merit list as per admission calendar 2024.

## 6. RESERVATION OF SEATS

- 6.1 Reservation for SC/ST/Kashmiri Migrant candidates will be as per the provisions of GOI for all programs.
- 6.2 10% seats at JUET, Guna are reserved for wards of serving and retired Armed Forces and Paramilitary Forces Personnel.
- 6.3 A concession of 30% in tuition fee is available for the candidates admitted under the categories given in point 6.2 above. An additional 5% concession in tuition fee is also available for the wards of war widows and personnel killed in action..

## 7. ADMISSION PROCEDURE - JEE (MAIN) 2024 RANK BASED BTech ADMISSION

- 7.1 The merit list amongst the Applications received for admission to Jaypee Universities shall be drawn on the basis of All India Rank in JEE (Main) 2024 Examination. Rank in no other category will be considered for drawing merit.
- 7.2 **CHOICE(S) OF INSTITUTES/BRANCHES** - During counselling, the candidates will be required to select any one Institute/University and give choice for any/all the programs of that Institute/ University.
- 7.3 **COUNSELLING INTIMATION:**
  - a) Counselling dates shall be displayed on the website of the University.
  - b) Intimation of counselling shall be sent to all short listed candidates on their registered e-mail IDs. Thus all candidates must ensure the correctness of their e-mail IDs while filling the application form and check all folders (including spam) of their e-mail for communication on counselling.
  - c) Ignorance/lapses, if any, in participating in the allotted counselling slot shall not be accepted as an excuse to participate in counselling at a later date.

## 7.4 COUNSELLING

The first round of counselling will be common and conducted at JIIT Noida for admissions to all the four universities, i.e. JIIT-Noida, JUIT-Waknaghat, JUET-Guna and JU-Anoopshahr. The subsequent round (s) of counselling will be held in respective Universities.

## 7.5 Process of Counselling:

- a) 1st round of counselling shall be held at JIIT-Noida on 25-26 June 2024. Candidates are advised to check their Email for the counselling intimation.
- b) All candidates (including those appearing in 10+2 examination in 2024) are required to upload their results on getadmissions portal latest by 10 June, 2024.
- c) Candidates called for counselling shall be permitted to exercise choice of only one University at the time of counselling.
- d) Candidates shall be allowed to exercise choice of any program/branches within the selected University.
- e) Allocation of seats will be done as per merit prepared based on all India rank of JEE (Mains) 2024.
- f) Seats in the programs shall be allocated on the basis of preferences indicated at the time of counselling.
- g) The candidate shall have the option of up-gradation in the programs /branches as per the merit and priority of choices exercised by them but within the same university.
- h) During counselling a candidate can confirm the seat available or choose to be in waitlist by depositing Rs. 75000/- (seventy five thousand). The amount will be adjusted against academic fee dues of first semester for candidates who are offered admission or will be kept as wait listed fee till admission is offered.
- i) Fee can be deposited through Debit Card/credit Card / UPI / Demand Draft favoring “Jaypee Institutes Admission Account” payable at Noida/Delhi. (Cheque and Cash are NOT acceptable.)
- j) On allocation of a seat, candidate will be offered Provisional Admission Letter.

### Note:

- i. Candidates are advised to judiciously fill their choice form at the time of counselling.

## 8. ADMISSION PROCEDURE – 10+2 MARKS BASED B TECH ADMISSION UNDER NRI CATEGORY

- 8.1 The merit shall be drawn, amongst the applications received under NRI /NRI sponsored category, based on the marks obtained in three subjects in 10+2 as given in Section 4.1 (b) under General Eligibility Criteria.
- 8.2 Candidates will be allotted seats strictly in order of merit. Selected candidates will be offered provisional admission, subject to production of certificates of eligibility/ qualification and depositing of applicable Academic fee. The selected candidates will be informed about the allotted seats along with other relevant information through e-mail by the respective Universities. The candidate must therefore give their correct primary Email ID for communication.
- 8.3 Candidates who take admission under this category cannot opt for change to General/ Non-NRI category in subsequent years of the entire program duration.
- 8.4 Those who have already passed 10+2 examination should fill 10+2 marks in the application form and attach a photocopy of the marks sheet.

- 8.5 Candidates appearing in 10+2 examination of year 2024 should submit their results by the last date of application. Candidates who fail to submit their 10+2 marks sheet by the due date will not be considered for admission.
- 8.6 All candidates should compulsorily attach Sponsorship Letter from NRI or NRI certificate, as the case may be, along with the application form.
- 8.7 In case of offline application form, the completed application form must be submitted or sent to the University on the address given in para 5.3(d) above. On the top of the envelope, please mention 'Application under NRI/ NRI Sponsored Category'

## 9. ADMISSION PROCEDURE - 10+2 MARKS BASED BTech ADMISSION

9.1 A separate application form must be filled by the students for each University seeking admission in B.Tech programs on the basis of 10+2 marks .

### 9.2 Counselling Process :

- a) JIIT Noida, JUIT-Waknaghat, JUET- Guna and JU-Anoopshahr will hold separate counselling for candidates seeking admission based on merit of 10+2 marks at their respective Universities on the scheduled dates mentioned above in the admission calendar 2024. Any change in the admission calendar 2024 will be notified for the information of the candidates well in time, by the university.
- b) The merit shall be drawn, amongst the applications received under 10+2 marks based admission, based on the marks obtained in three subjects in 10+2 as given in Section 4.1 (b) under General eligibility Criteria.
- c) For admission, the candidates will be asked to participate in the counselling process by registering themselves for admission based on 10+2 marks. The candidate will have to provide the 10+2 marks and update the 10+2 marks sheet through the link provided through email after declaration of 10+2 result.

### 9.3 Allocation of Seats

Seats in the programs of study shall be allotted on the basis of preferences opted by the candidate, strictly in order of merit drawn based on marks scored in 10+2 in the 3 subjects as given in para 4.1 (b).

## 10. ADMISSION PROCEDURE-LATERAL ENTRY ADMISSION TO 2ND YEAR BTech PROGRAM

10.1 Application forms must be filled by the students seeking direct admission to BTech 2nd Year.

### 10.2 Eligibility:

- a) Passed Diploma examination with at least 45% marks (40% for SC/ST) in the same branch in which admission in BTech 2nd year is sought.
- b) Passed BTech 1st Year with at least 45% marks (40% for SC/ST) or equivalent CGPA in the same branch in which admission in BTech 2nd year is sought.
- c) Passed BSc Degree from a recognized University as defined by UGC, with at least 45% marks (40% for SC/ST) and passed 10+2 with mathematics as a subject.
- d) Passed D.Voc stream in the same or allied sector.

### 10.3 Admission Process:

Based on the application received and meeting the eligibility criteria, merit shall be prepared based on CGPA/Marks obtained in BTech 1st Year / Diploma / D.Voc. Admission shall be offered based on the merit.

## 11. ADMISSION PROCEDURE - DIPLOMA PROGRAM

- 11.1 The candidate should have passed 10th or equivalent examination to be eligible for admission and should be graded "Pass" by the board. Candidates appearing in the qualifying examination 2024 can also apply for admission. However they will be required to submit results of qualifying examination before the due date which will be notified by Email.
- 11.2 Admission will be based on merit drawn on the basis of marks obtained in 10th or equivalent examination.
- 11.3 Merit List of qualified candidate will be prepared and selected candidates will be offered admission.

## 12. ADMISSION PROCEDURE - MSc PROGRAM

- 12.1 Candidates who have passed the qualifying examination should provide marks of the qualifying examination along with the application form and attach a photocopy of the marks sheet. They will be required to submit results of qualifying examination before the due date which will be notified by e-mail.
- 12.2 **Admission Process**  
A merit will be drawn, on the basis of marks of qualifying examination results. Selected candidates will be offered provisional admission subject to production of eligibility certificates and deposition of Academic fee.

## 13. ADMISSION PROCEDURE - MTech PROGRAM

- 13.1 Candidates who have passed the qualifying examination should provide marks of the qualifying examination in the application form and attach a photocopy of the marks sheet.
- 13.2 Candidates appearing in qualifying examination 2024 for admission can also apply. However, they will be required to submit results of qualifying examination before the due date which will be notified by e-mail.
- 13.3 The Application Form completed in all respect should be sent to The Admission Cell, Jaypee University of Engineering and Technology, AB Road, Raghogarh, Guna-473226 (MP)
- 13.4 **Admission Process:**  
Candidates meeting the eligibility criteria will be required to appear in the PGET conducted by JUET, Guna. A merit will be drawn, on the basis of marks obtained in PGET. Selected candidates will be offered provisional admission subject to production of eligibility certificates and deposition of Academic fee. GATE qualified candidates are exempted from appearing in PGET.

## 14. ADMISSION PROCEDURE PhD PROGRAM

- 14.1 Candidates who have passed the qualifying examination should provide marks of the qualifying examination in the application form and attach a photocopy of the marks sheet.
- 14.2 Candidates appearing in qualifying examination 2024 can also apply for admission. However, they will be required to submit results of qualifying examination before the due date which will be notified by e-mail.
- 14.3 Hard copy of the application form completed in all respect should be sent to the Admission Cell, Jaypee University of Engineering & Technology, AB Road, Raghogarh, Guna 473226(MP).
- 14.4 **Admission Process:**  
Admission to PhD Program will be done through PhD Entrance Test followed by interview conducted by JUET Guna. NET/SLET/GATE qualified candidates are exempted from appearing in PhD Entrance Test. However, they will be required to appear for the interview conducted by the respective department. Admission will be offered purely on the basis of PhD Entrance Test Result and/or Interview. The admission will be provisional and subject to production of eligibility certificates and deposition of academic fee.

## One Time Charge:

- (i) **Caution Money** - Caution Money of Rs. 20000/- is to be deposited at the time of admission for B.Tech programs and Rs. 5000/- for all other programs. The caution money is a one-time charge which is refundable after completion of the program.
- (ii) **Counselling Charges** – One-time non-refundable counselling charge to be deposited by all candidates at the time of admission as follows:

## 16. REFUND POLICY

Last date of admission is as allowed /communicated by regulatory bodies. If a student leaves the program, fee shall be refunded as per UGC/AICTE Notifications.

### Refund of Hostel Charges:

- a) Till the date of Registration in program, a candidate is entitled for full refund of advance of Hostel charges, provided the student does not occupy the Hostel in advance.
- b) From the date of Registration in the program, the amount shall be refunded on pro-rata monthly basis, even if student has not occupied the Hostel or not taken the key to the room.
- c) For calculation of pro-rata deduction/refund, the duration of the semester as per the academic calendar shall be considered and deduction shall be made on per month basis, even if hostel is occupied for part of a month i.e. even for a single day only.
- d) Refund after reporting at the allotted University is subject to submission of No Dues.

## 6. RESERVATION OF SEATS

6.1 Reservation for SC/ST candidates will be as per the provisions of GOI for all the programs.

6.2 For B.TECH admissions, 50% seats shall be filled through counselling based on JEE (Main) 2024 All India Rank and remaining 50% seats shall be filled through counselling based on merit, drawn on the basis of marks of 10+2 examination/CUET-UG.

6.3 10% seats at Jaypee University, Anoopshahr are reserved for wards of serving and retired Armed Forces and Paramilitary Forces Personnel.

6.4 All vacant seats are inter-transferable in all categories

## 7. ADMISSION PROCEDURES – BTech PROGRAMS (JEE MAIN 2024 AIR BASED)

- 7.1 Candidate's who have passed 10+2/equivalent exam in 2022, 2023 or appearing in 2024 are eligible to apply.
- 7.2 Candidates with gap year (if any) between their 10+2 and admission to UG programs will be required to submit a Gap Period Affidavit (available at the university website).
- 7.3 Candidates should have minimum of 60% marks (55% for SC/ST) in aggregate in 10+2 or equivalent examination and should have secured a Pass grade in all subjects.
- 7.4 The candidate should have passed or appeared in 10+2 examination or its equivalent with Physics and Mathematics as compulsory subjects along with one subject out of Chemistry, Computer Science, Electronics, Information Technology, Biology, Informatics Practices, Biotechnology, Technical Vocational Subject, Agriculture, Engineering Graphics, Business Studies, Entrepreneurship.
- 7.5 The merit list amongst the Applications received for admission to Jaypee Universities shall be drawn based on JEE (Main) 2024 AIR. Rank in no other category will be considered.
- 7.6 **CHOICE(S) OF INSTITUTES/BRANCHES** - During counselling the candidate will need to select any one Institute/University and give choice for any/all the programs of that Institute/ University.
- 7.7 **COUNSELLING INTIMATION:**
- Counselling will be based on Merit. Candidates eligible for counselling on a specific date will be informed.
  - Intimation will be sent by Email on registered mail ID's.
  - Ignorance/lapses, if any, in participating in the allotted counselling slot shall not be accepted as an excuse to participate in counselling at a later date.

### 7.8 COUNSELLING

The first round of counselling will be common and conducted at IIIT Noida for admissions to all the four universities, i.e. IIIT-Noida, JUIT-Waknaghat, JUET-Guna and JU-Anoopshahr. The subsequent round (s) of counselling will be held in respective Universities.

#### Process of Counselling:

- 1st round of counselling shall be held at IIIT-Noida on 25-26 June 2024. Candidates are advised to check their Email for the counselling intimation.
- All candidates (including appearing in 10+2 examination in 2024) are required to upload their results on getadmissions portal latest by 31 May, 2024.
- Candidates called for counselling are permitted to exercise choice of only one University at the time of Counselling (No inter-university transfers are allowed).
- Allocation of seats will be as per merit of JEE(Mains) 2024 AIR.
- Candidates shall be allowed to exercise choice of any program/branches within the selected University (Thus, the candidate shall have the option of up-gradation in the programs /branches as per the merit and priority of choices exercised by them but within the same university).
- Seats in the programs shall be allocated on the basis of preferences indicated at the time of counselling.
- During counselling a candidate can confirm the seat available or choose to be in wait list by depositing Rs. 75000/- (seventy-five thousand). The amount will be adjusted against academic fee dues of first semester for candidates who are offered admission or will be kept as wait listed fee till admission is offered.
- Fee can be deposited through Debit Card/credit Card / UPI / Demand Draft favoring "Jaypee Institutes Admission Account" payable at Noida/Delhi. (Cheque and Cash are NOT acceptable.)
- On allocation of a seat, candidate will be offered Provisional Admission Letter.

#### Note:

- Candidates are advised to judiciously fill their choice form at the time of counselling.
- The candidates have the option of freezing confirmed seats allotted to them any time before up-gradation is carried out, if they are satisfied with their allotted program and they do not want any further changes through up-gradation.

## 8. ADMISSION PROCEDURES – BTech PROGRAMS (10+2 MARKS BASED), BTech (LATERAL ENTRY) AND OTHER DIPLOMA / UG / PG PROGRAMS

- 8.1** The admission will be offered to the eligible candidates as per merit drawn based on aggregate percentage in the qualifying examinations as applicable to different programs.
- 8.2** All candidates who are offered provisional admission will be required to pay the advance fee for reservation of their seats (latest by the date as mentioned in the provisional admission offer letter), and produce proof of having passed the qualifying examination to the University authorities latest by September 30, 2024, failing which, such provisional admission will stand automatically cancelled. No representation for extension of dates, for whatsoever reasons, shall be entertained.
- 8.3** All admissions will be subject to verification of facts from the original certificates/documents of the candidates. If an applicant is found ineligible at a later stage after admission to the University, the admission will stand automatically cancelled. The decision of the Admissions Committee of the University regarding the eligibility for admission to the program shall be final and binding on the candidate.
- 8.4** Ensuring eligibility for the admission to the program, under the defined category of admission, is the sole responsibility of the candidate.
- 8.5** Candidates appearing in qualifying examinations prescribed above in the year 2024 can also apply for admission. However, if admission is based on marks merit, the result must be submitted before the preparation of merit as per admission calendar 2024.

**4. CONCESSION IN FEE FOR STUDENTS FROM JAYPEE SCHOOLS ADMITTED TO JAYPEE UNIVERSITY ANOOPSHAHR**

- (a) The mentioned concession shall be applicable to the students of Jaypee Schools across Pan India whereas they shall be eligible for award of 10 % of concession in Tuition Fee as applicable to the respective programs/ Batches of their entry.

(b) The above concession in Fee shall be applicable for 1st year only. The same may be continued in subsequent years (Minimum duration of the program) subject to achieving the minimum CGPA of 6 on a scale of 10 at the end of each academic year.

(c) The above shall be applicable for the students admitted to Diploma and UG programs only.

#### 5. FINANCIAL ASSISTANCE (PAYMENT OF FEE IN INSTALMENTS):

It has been observed that many of students are not able to pay their fees in advance for the semester whereas Jaypee University believes that money should not be barrier for students to pursue their studies.

Considering above, it is permitted to charge the fee from students (who are not able pay their fee in advance for the semester/year and having parent's income of less than Rs. 2.0 lakh per annum), on monthly basis. However the following criteria/terms & conditions are required to meet for the same:

(a) The student must approach the University's authority requesting his/her inability to pay full fee in advance and accept the fee payment on monthly basis along with the submission of income certificate as required.

(b) The payment of fee on monthly basis shall be applicable on Total Fee (except Caution Money and JYC Charges) which shall be divided by 10 and accordingly the fee dues shall be made for the concerned student on monthly basis.

#### 6. TERMS AND CONDITIONS

- The student shall be eligible for any one scholarship at a time as given in Section 1 to 4.
- During the first semester, the student shall be required to pay the full fee however scholarship awarded for the first year will be considered/adjusted in the Fee dues for 2nd semester along with the regular scholarship of 1st semester as applicable.

## 11. REFUND POLICY

11.1 The Application Fee is not refundable.

11.2 In case of withdrawal, the Academic Fee shall be refundable as per UGC/AICTE Norms. Last date of admission shall be notified/communicated as per the policy/instructions by regulatory bodies.

11.3 Refund of Hostel Charges:

- Till the date of registration, a candidate is entitled for full refund of advance Hostel Charges, provided the student does not occupy the Hostel in advance.
- From the Date of Registration in the program, the amount shall be refunded on pro-rata monthly basis, even if the student has not occupied the Hostel or not taken the key to the room.
- For calculation of pro-rata charges, the duration of the semester shall be considered as five (5) months and deduction /refund shall be made on per month basis even if the hostel is occupied for part of a month i.e. even for a single day.

## 12. RAGGING

Ragging in any form is banned inside and outside the campus. Note that ragging is a criminal offence and punishable act. The Supreme Court of India has also defined ragging as a criminal offence.
