This is regarding Pre-qualifiers submitted by **Jaypee University of Information Technology, Post Wahnaghat, Tehsil Kandaghat, Solan- 173234, Himanchal Pradesh** for the UG Engineering program in whose case the period of accreditation in Tier I has expired on 30.06.2021.

2. 
