The session aimed to bridge the gap between academic research and industry applications by highlighting structured innovation pathways, IP protection mechanisms, and commercialization strategies.

Objective of the Session

The key objectives of the expert lecture were:

- To introduce students to the concept of **Technology Readiness Levels (TRLs)** and their importance in innovation assessment.
- To explain the process of **technology transfer** from laboratory to industry.
- To create awareness about **intellectual property rights (IPRs)** including patents, copyrights, trademarks, and trade secrets.



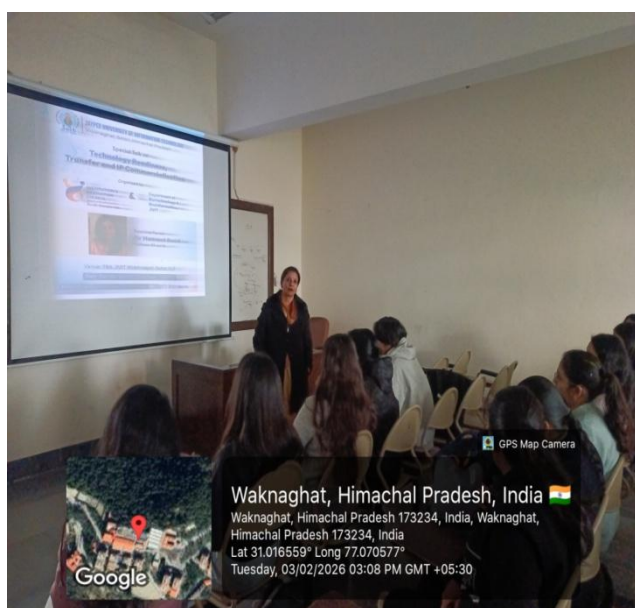
- To discuss strategies for **IP commercialization** through licensing, start-ups, and industry partnerships.
