Dear Candidate,

1. I have great pleasure in informing you that based on your M. Tech. Entrance Test -2021 and relative merit in the program; you have been provisionally admitted to M. Tech program at Jaypee University of Information Technology, Wazirpur, New Delhi for the Academic Session 2021 – 22. The allocation of Branch is final and no requests for change shall be entertained. The admission is subject to meeting eligibility criteria for admission to the program.

Fee Structure & Deposition Schedule

2. **Fee Structure:**
 - a) Tuition Fee: Rs. 50,000/- per semester (Rs. 1,00,000/- per year).
 - b) Hostel Charges: Rs. 63,000/- per semester (Rs. 1,26,000/- per annum) for occupancy of 10 months in an Academic Year. Availability of hostel as per orders for on campus academic activities by Govt. of India/HP Govt./Regulatory Bodies and room will be allotted based on merit and availability.
 - c) Caution Money : Rs. 10,000/- (One time deposit at the time of registration and refundable after completion of the program)
3. To confirm your admission, you are required to deposit Rs. 60,000/-(Rupees Sixty Thousand Only) **towards Tuition Fee for semester and (refundable Caution Money of Rs. 10000/-) latest by September 20, 2021** through RTGS/NEFT: (Do not forget to send your UTR No. to mail ID as given below) Account Name: Jaypee University of Information Technology; Account Number: 0427032100000010; Bank Name: Punjab National Bank, Branch: JUIT, Wazirpur, IFSC Code: PUNB0637100, Account Type: Current.

Mention your name and your father's name while transferring the fees and send the full details to CFO, Mr. Hemant Vyas at finance@juit.ac.in / hemant.vyas@juit.ac.in cc to amitk.shrivastava@juit.ac.in with your Unique Transaction Reference (UTR) Number. It will ensure linking of your transfer.

4. **In case you do not deposit the Fee by due date, your candidature shall be cancelled. No representation to extend the date of submission of fees is accepted under any circumstances.**
5. You are requested to send scanned self attested PDF copies of documents in one PDF file establishing your fulfilling the eligibility criteria for the admission to the program through e-mail to arindam.das@juit.ac.in . The details of the documents are as under:-

- Character and Transfer/Migration certificate from the Head of the Institute/Board last attended.
- Self attested copies of Marks Sheets and Certificate of High School, Intermediate and Under Graduate or equivalent.
- Medical certificate of fitness from MBBS qualified doctor on his/her letter head or letter head of the hospital (as per format given in the download section of the University website only be considered: <https://www.juit.ac.in/downloadforms/Medical-CertificateProforma.pdf>) indicating that you are free from any communicable disease. In case any student is suffering from or ever suffered from diseases which need immediate medical attention like Congenial Heart disease, Rheumatic Heart Disease, Hypertension, Bronchial Asthma, Seizures, Diabetes Mellitus or Psychiatry related diseases etc, must be declared in the medical certificate so as to enable quicker and suitable response in case of emergency.

NOTE: In case you are not able to submit any document listed above for reason beyond your control, you should submit the same latest by December 31, 2021 after giving an undertaking on format at link: <https://www.juit.ac.in/downloadforms/UNDERTAKING.pdf> . In case you fail to submit the supporting documents proving your eligibility for admission to the program by the stipulated date, your admission to the program shall stand cancelled automatically and no claim thereafter shall be entertained.

Antiragging
