INSTRUCTIONS TO SELECTED CANDIDATES

(PhD : ACADEMIC YEAR 2022-23)

Dear Candidate,

1. I have great pleasure in informing you that based on your PhD Entrance Test and relative merit in the program; you have been provisionally offered admission to PhD program at Jaypee University of Information Technology, Wagnaghat for the Academic Session 2022 – 23. The allocation of Branch is final and no requests for change shall be entertained. The admission is subject to meeting eligibility criteria for admission to the program.

Fee Structure & Deposition Schedule

2. **Fee Structure:**
 - a) Tuition Fee: Rs. 27,500/- per semester (Rs. 55,000/- per year).
 - b) Hostel Charges: Rs. 80,000/- per semester (Rs. 1,60,000/- per annum) for shared occupancy of 10 months in an Academic Year. Hostel seat will be allotted based on merit and availability. Be informed that hostel charges are market driven and are subject to revision each academic year. Those desirous of single room are required to pay Rs. 7500/- per semester in addition to above. These rooms are extremely limited & are on first come first serve basis..
 - c) Caution Money : Rs. 10,000/- (One time deposit at the time of registration and refundable after completion of the program)
3. To confirm your admission, you are required to deposit Rs. 37,500/- (Rupees Thirty Seven Thousand Five Hundred Only) which includes Rs. 27500/- towards Tuition Fee for First Semester and refundable Caution Money of Rs. 10000/- latest by August 27, 2022 through RTGS/NEFT: (Do not forget to send your UTR No. to mail ID as given below) Account Name: Jaypee University of Information Technology; Account Number: 0427032100000010; Bank Name: Punjab National Bank, Branch: JUIT, Wagnaghat, IFSC Code: PUNB0637100, Account Type: Current..

Mention your name and your father's name while transferring the fees and send the full details to CFO, Mr. Hemant Vyas at finance@juit.ac.in / hemant.vyas@juit.ac.in cc to amitk.shrivastava@juit.ac.in with your Unique Transaction Reference (UTR) Number. It will ensure linking of your transfer.

4. In case you do not deposit the Fee by due date, your candidature shall be cancelled. No representation to extend the date of submission of fees is accepted under any circumstances.

Registration Schedule

5. Your Registration for the First Semester is scheduled for September 06, 2022
6. You are required to bring the following original and photocopy of documents establishing fulfilling the eligibility criteria for admission to the program at the time of Registration. The photocopies should be self attested
- Character and Transfer/Migration certificate from the Head of the Institute/Board last attended.
 - Self attested copies of Marks Sheets and Certificate/Degree of High School, Intermediate, Under Graduate and Post Graduate or equivalent.
 - Medical certificate of fitness from MBBS qualified doctor on his/her letter head or letter head of the hospital (as per format given in the download section of the University website only be considered: <https://www.juit.ac.in/downloadforms/Medical-CertificateProforma.pdf>) indicating that you are free from any communicable disease. In case any student is suffering from or ever suffered from diseases which need immediate medical attention like Congenial Heart disease, Rheumatic Heart Disease, Hypertension, Bronchial Asthma, Seizures, Diabetes Mellitus or Psychiatry related diseases etc, must be declared in the medical certificate so as to enable quicker and suitable response in case of emergency.

NOTE: In case you are not able to submit any document listed above for reasons beyond your control, you should submit the same latest by 30th September 2022 after giving an undertaking on format at link: <https://www.juit.ac.in/downloadforms/UNDERTAKING.pdf> . In case you fail to submit the supporting documents proving your eligibility for admission to the program by the stipulated date, your admission to the program shall stand cancelled automatically and no claim thereafter shall be entertained.

Anti Ragging
