It is bring to your kind notice that Himachal Pradesh Backward classes Finance and Development Corporation Kangra is implementing an Educational loan scheme for the students of Backward Classes for professional/technical courses at graduate and higher level approved by appropriate authority.

Under this schemes the maximum loan amount limit is Rs. 15.00 lakh per student India and Rs. 20.00 lakh per student if he/she wants to study abroad @ rate of interest 4% per annum for boys and 3.5% per annum for girls to those who are members of backward classes as notified by Central Government/State Government from time to time and whose annual family income does not exceed 3.00 lakh.

The applicant should have obtained admission for any professional and technical courses approved by appropriate agency such as AICTE, Medical Council of India, UGC etc. and are duly accredited/recognized institute and the application should have scored a minimum 50% marks in qualifying exam i.e. the exam whose qualification is a pre-requisite for the course.
