1. ARC will ensure compliance to UGC Regulations as well as provisions as per law currently in force concerning ragging.
2. ARC will monitor and oversee performance of Anti Ragging Squad/Anti Ragging Sub Committee in Prevention of Ragging in JUIT Waknaghat.
3. ARC will forward reports of ARC Minutes to Monitoring Cell of JUIT and shall keep itself abreast of the decisions of the district level Anti Ragging Committee headed by DM.
4. It shall take appropriate decision in regard to punishments or otherwise keeping in view the nature of gravity of incident of ragging established in recommendations of the Anti-Ragging Squad.
5. The ARC may award one or more of the following punishments:
 - (a) Suspension from attending classes and academic privileges.
 - (b) Withholding/Withdrawing Scholarship/fellowship and other benefits.
 - (c) Debarring from appearing in any test/examination or other evaluation process.
 - (d) Withholding results.

- (e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- (f) Suspension/expulsion from the hostel.
- (g) Cancellation of admission.
- (h) Rustication from the institution for period ranging from one to four semesters.
- (i) Expulsion from the institution and consequent debarring from admission to any other institution, for a specified period.
